TECHNICAL AND ENVIRONMENTAL HEALTH SPECIFICATION

Product specification

The prefabricated concrete paving flags and complementary fittings are intended for use in trafficked paved areas and roof coverings. The quality of the products is first determined by law at 35 days of age, exclusive frost days (average twenty-four hour temperature less than 5°C). Concrete paving flags can be used in building works which come into contact with rain water, ground water and/or surface water

Environmental health specification

The average composition values determined by agreement AP 04-SB and the average emission determined by agreement AP04-U for the intended field of application comply with appendix A of the Soil Quality Decree.

Conditions for application

Concrete paving flags should be applied in accordance with articles 5, 6, 7 and 33 of the Soil Quality Decree (functionality, duty to maintain and recycling).

Marks and indications on the delivery documents

Every package of concrete paving flags will be marked with:

- The KOMO® image or work mark and the identification of the manufacturer (logo and/or K number);
- Production date.

Additionally the delivery note will be marked with the KOMO® image or word mark in accordance with the figures below:

The KOMO® image or word mark is clearly visible on the delivery note.

The KOMO® products on the delivery note are marked by means of coding, such as "KOMO" or "K".

- Identification of the chosen classes of the European standard or a reference to the national preface in NEN-EN 1339;
- The number of the European standard NEN-EN 1339;
- Identification of the date if the products are delivered before the date they are declared suitable for use.

- The products show no visible defects resulting from transport and suchlike.
